Sam Colacarro '62



Sam Colacarro was born and raised in "Little Italy" in Cleveland, Ohio. He always wanted to attend Cathedral Latin from his early days in the 1950s. His father would take him to Latin games that he still finds legendary to this day.

Sam was the son of a father who worked as a maintenance technician at St. Vincent Charity Hospital. His mother quit school after 10th grade to work. Colacarro, along with his two brothers, Frank '64 and Bob '67, learned too early

Clinton Jones '63



Clinton Jones was raised in a blue-collar neighborhood in Cleveland, Ohio by his mother and grandmother. His mother was a constant presence in his life. She gave birth to him at the age of 15 and worked several jobs to make ends meet and take care of Clinton, her only child. When she was 20 years old, she was able to buy their own home.

Jones transferred to a private Catholic school in the fourth grade. The black population in elementary and

Building Our Heritage at NDCL



It is hard to believe that I am approaching the completion of my third year as President of the Cathedral Latin Alumni Association. It has been an honor to serve all of you in that capacity. I've enjoyed every minute of my service.

All of our archives have been moved to NDCL and are stored in the Archives Room on the school's second floor. Sr. Joanne Keppler, SND is categorizing and organizing the items which will then be inventoried in a

computerized system. A display, which we hope to be built this year, will showcase our school's history and heritage using key archived items on the wall opposite the trophy cases in the McGarry Gym building.

Last year, we achieved our initial goal of having a \$160,000 balance in the Brother Nurthen Endowed Scholarship Fund. The current balance is \$175,395. Each year, the fund provides a \$1,000 scholarship to eight select NDCL students who are related to Cathedral Latin alumni. We agreed to continue to build that fund in hopes to double the initial target balance to a total of \$320,000 and to provide \$2,000 scholarships in the future.

In 2018, we committed to a \$15,000 donation toward the renovation of the boys locker room at NDCL — \$7,500 in 2018 and \$7,500 in 2019. The boys locker room had not been upgraded since NDCL was founded in 1988. The renovations were completed in the fall of 2018 as part of the school's effort to upgrade that facility along with the weight room facility. We hope you can stop in at NDCL to see these wonderful renovations.

As always, I would like to thank everyone who made a donation in any way to our alumni association whether for annual dues, memorial gift or Brother Nurthen Fund. Your donations keep the alumni association alive and active and help to support our namesake school, NDCL, and the students who attend.

An All-Star on the Sidelines

As many of the athletes for Cathedral Latin will acknowledge, there is a group of “Unsung Heroes” who provided the much needed and appreciated support for our games. They secured and maintained the sport’s required equipment, uniforms, medical packs and water for practices, inter-school scrimmages and competition games.

Who were these guys, you ask? They were our equipment managers. These men were in the locker room before practices and games and on the practice field and sidelines ready to help. They readied the uniforms and other required equipment prior to the start of practices and games. Without them, there would be no games.



One of these unsung heroes at Cathedral Latin was Pat Grady, Class of 1966. Pat was well-remembered by those he served and those he worked with in the background. He was a four-year student manager. Pat was a Freshman football manager, a JV

Football Manager and a two-year Varsity Football Manager. Very few of the student managers at Latin performed those duties for four years.

Pat earned his class numbers as a freshman manager, a JV letter as a junior varsity manager and then earned varsity letters in both his junior and senior years as the head manager those last two years.

Note that, even though each sport at Latin had its own set of managers, Pat was considered by all as the leader and as the one manager who set the standard of performance for all others. He was the man behind the scene who made considerable contributions to enable our stars to shine.

His abilities were so respected by those in the Athletic Department that often Coach Sam Ruvolo would go directly to Pat for his support requests — bypassing the assistant athletic director.

Many on the 1965 varsity football team considered Pat to be their version of Daniel Eugene Ruettiger — also known as Rudy of Notre Dame fame. Myron Achbach writes, “He epitomized the significance of athletic managers at Latin. He loved being associated with the

teams and felt honored to be part of such a great tradition. Always cheerful, there was never any task too menial or unimportant to Pat.”

After graduation, Pat received a four-year athletic scholarship to the University of Dayton as a student trainer. Normally, in 1966, athletic scholarships were not offered to student trainers, but Dayton placed so much value on Pat’s skills and held such a high regard for what he could contribute to the Athletic Department, that they decided to offer him the scholarship.

Pat lived in the Dayton area for many years. After graduating from UD, he joined the U.S.M.C. and then settled into a long career with Yellow Pages.

Of extreme interest, besides his story as a student manager at Latin and a trainer at the University of Dayton, is the story of his survival from some serious health issues and of his faith in God. Several years ago, Pat contracted a lung disease that put his life in jeopardy and he was in need of a double lung transplant. At a point where doctors told him that he had only two weeks to live, a lung donor was found and he underwent a successful double lung transplant. With much prayer and support from family and friends, Pat survived that transplant and some related problems with an anti-rejection medication that caused cancer.

Pat Grady is now living happily and in good health in Punta Gorda Isles, Florida with Cindy, his wife of more than 49 years. They have three children and six grandchildren.

He is truly an unsung hero from Cathedral Latin School.



Thomas W. Hoban, Class of 1931

While at Cathedral Latin, Tom Hoban was an all-scholastic guard and captain on the 1930 Cathedral Latin football team and played for coach Herb Eisele. The team had a record of 6-2-1. After high school, Tom went on to play for the University of Dayton. In 1970, Hoban was inducted into Latin's Athletic Hall of Fame.



But it was off the football field where Tom excelled. He joined the U.S. Army after college. On December 1942, in the vicinity of Tunisia, he distinguished himself while conducting the defense of a position against constant attack by enemy ground troops supported by artillery and machine gun fire as well as serial bombardment and strafing. Tom didn't think about his own safety and personally led three counter-attacks to recover lost ground.

On January 15, 1943, Hoban was personally decorated by General George Patton, who awarded him the Distinguished Service Cross. This award was for extraordinary heroism in action against an armed enemy. He was also awarded the Purple Heart three times. Tom was a major and later retired as lieutenant colonel. He served as president of retired members of the First Armored Division in Fort Knox, Kentucky.



Hoban was very proud of the First Armored Division and the friends he made. His wife, Helen, was also in the service. She served in the Navy, so there was always a friendly rivalry when the Army/Navy game was played.

Tom passed away from heart disease on April 26, 1975 at the young age of 63. He will be remembered as a true hero and Latin Lion who served "in deed and truth."

Brother Nurthen Scholarship Fund Helping More Students

As many of you know, the Brother Frank Nurthen endowed scholarship fund was established by the Cathedral Latin Alumni Association in the 1990s at NDCL to provide tuition assistance to NDCL students who are relatives of Cathedral Latin alumni.



The fund provides eight \$1,000 scholarships for select students. When we established this fund, we set an initial target balance of \$160,000 to allow us to provide those scholarships without touching the principle. That initial target balance was achieved in 2018.

We recognize that tuition today is significantly more than it was when the fund was first established. This year, the CLAA Trustees voted to double the initial fund target balance. Our new goal of \$320,000 will allow us to offer eight \$2,000 scholarships to students.

We have created the Brother Nurthen Scholarship Committee headed by Tony DiGeronimo '68 (chairman), Rick Cavolo '74 and Terry Roncagli '77. Working together with the development team at NDCL, we hope to better understand the best way to achieve this new balance within the next couple of years.

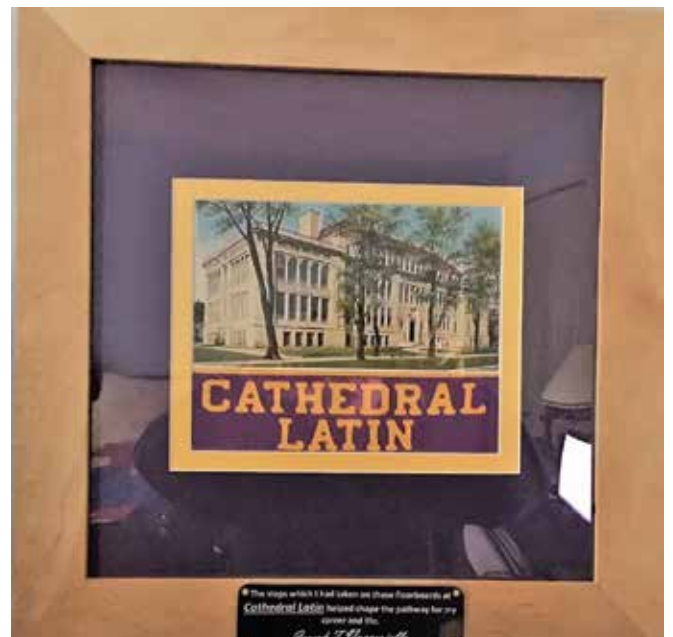

lessons — family comes first and there's nothing wrong with hard work to get what you want out of life.

While at Latin, Sam was a member of the golf team for three years. He was also a homeroom officer and involved in Knights of the Altar and Choral Club.

After high school, Sam attend John Carroll University where he majored in French and Spanish. He graduated with a degree in education.

Sam applied for several teaching positions at various schools in the area. A Spanish teaching position became available at Latin, so he interviewed and got the job. Teaching at his alma mater was something special for him.

During his first year at Latin, Sam also coached the golf team. That same year, Brother Tom Caffery called him and offered him the position of athletic director. After his initial shock, he took the position. He says he owes a great deal of thanks to Tom Ward, who was the football coach at that time. Tom guided Sam through that period and has always been an important figure in his career.

After three years as athletic director for Latin, he was contacted by the principal at Lake Catholic — a new high school in Mentor, Ohio — and was offered the same position. At the time there was only a freshman class and the school was starting to grow. Tom Ward had transferred to Lake and was their football coach. So once again, they worked together to produce a strong athletic program.

Lake Catholic is in its 49th year of existence, having opened in the 1970-71 school year and Colacarro has been the school's athletic director for 48 of them. Sam was only 27 years old when he came to Lake Catholic in 1972 in charge of an upstart athletic department.

Since coming to Lake Catholic, they have won five state championships, three in football, one in wrestling and one in volleyball. Two of the football state titles were under his classmate John Gibbons.

On February 18, 2017, Sam was honored for 50 years of service in Catholic education at Lake Catholic's annual gala at LaMalfa Party Center.

Sam continues on with the regimen he's followed for the past five decades, working behind the scenes to ensure the best possible athletic experience for the thousands

upon thousands of kids he's helped bring up over the years. "Above it all, above the wins, the best thing is when someone comes back, thanks you and tells you that you made a difference in their lives," says Sam.

Colacarro attributes much of his career happenings to the basic core values that he learned while a student at Cathedral Latin. He prides himself on doing things the right way and keeping within the Christian values that he learned at Latin.

He said he has no intention of retiring and hopes to continue as long as he's able. He enjoys his job and it's kept him young and he wouldn't trade it for anything.

Sam married Marianne in 1982 and they had two children — Dana and Tom. Dana is married to Troy and they have two children Jacob and Carter. In 2004 Marianne passed away from cancer and Sam remarried in 2007 to Tammy. He has a stepson, Ben. Sam says that he is blessed to have two women who have supported him and have been able to understand the long hours and time away from the family to perform his duties as athletic director.

high school was only 2% or less, but he had the support of his mother and grandmother. They made it happen. That decision changed his life and exposed him to opportunities and education that the public schools were not providing. "The racial divide was always there, but there were fewer blacks to deal with, so we weren't as threatening in numbers," says Clinton.

Attending Cathedral Latin showed his neighborhood boys he attended a school known for its excellence, not only in football and basketball, but as one of the premier schools for academics. The "Fighting Lions" changed his life and exposed him to mentors who loved and cared for him. While at Latin, Clinton excelled in track and football. Dick Marabito was his track coach as well as defensive line coach in football.

After Latin, Jones attended Michigan State University. He had a great career in both football and track. In 1964 he was named Mr. Michigan State University. This was the first time in the school's history that a minority and a sophomore was voted for this honor. Jones writes about his time with the team, "...we came together as a

team and really jelled. There was civil unrest and the country was in turmoil, but on the MSU campus, we took the off-the-field adversity and turned it into opportunity. Despite our uniqueness and different life experiences, we focused on each other and developed a special bond. It was more than just about football.”

He also enjoyed working within the East Lansing Community and received the 1966 Big Brothers of America “Big Brother of the Year” award. It meant a lot for Clinton to be a role model for his “little brother.”

In 1967, he was drafted into the NFL and played for the Minnesota Vikings where he participated in the Super Bowl against the Kansas City Chiefs. He was traded in 1973 to the San Diego Chargers. In 1972, he was inducted into the Cathedral Latin Sports Hall of Fame. After a knee injury, Jones retired in 1975 after his contract expired.

He enrolled in Cleveland Chiropractic College for four years of study in July 1975. During this period, he worked in the evenings as a correctional officer (youth counselor) at Ventura School Correctional Facility with convicted felon juveniles. He received his Doctorate of Chiropractic in 1979, passed his state board exams in 1980 and received his California Chiropractic license in 1981. He has been in practice as a chiropractic doctor with his wife, Rosielee (also a chiropractor), for over 48 years in California.

In 2012, Clinton entered the Greater Cleveland Sports Hall of Fame and Michigan State Hall of Fame. In 2015 he entered the National Football Foundation College Hall of Fame.

Nichiren Buddhism was introduced to Clinton by his wife, Rosielee, in 1977. He joined The Soka Gakkai of the United States of America. This is the largest lay Buddhist organization with a collective goal: To realize world peace through each person becoming happy. Buddhism has had a profound effect on every aspect of his life.

Jones is grateful for the opportunity to attend Cathedral Latin and Michigan State where he received a great education and formed lifelong friendships that continue today.

Clinton has been married to Rosielee Jones, D.C. for almost 40 years and been in chiropractic practice together since 1980. They have five daughters – Dywana, Stephanie, Tiffany, Shani and Cara, and seven grandchildren.

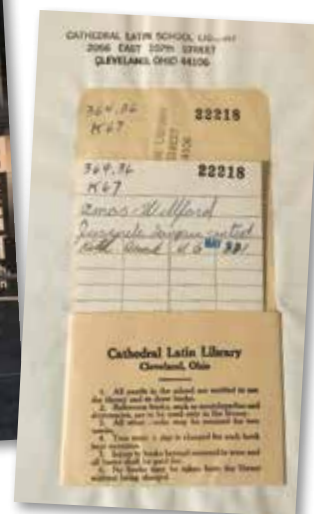
